## In The News...

New study reveals dramatic discrepancy between FDA's reporting on serious adverse events related to the abortion pill and the raw numbers demonstrated by insurance claim data analysis. The approval process for Mifepristone (the abortion pill) has been fraught with controversy from its inception in the mid-1990s. With encouragement from the Clinton administration, the FDA accepted the application for approval submitted by the eugenics based organization Population Council in 1996. It was approved by the FDA under a little-used approval process for "certain new drug products that have been studied for their safety and effectiveness in treating serious or life- threatening illnesses." In essence, the FDA had to consider pregnancy a serious or life-threatening illness to grant approval so quickly. Four years later, the initial approval was granted under a strict criteria-based process. A couple of these criteria included a 7-week gestational limit and hands-on physician contact over multiple appointments. Over the course of the next 2 decades, these safeguards have been chipped away leading to an increase in serious adverse event reporting, including maternal death.

The FDA altered safeguards but never updated the safety data. It continues to be reported that the risk of serious adverse events is 0.5%, as is documented on the drug label. The Ethics and Public Policy Center recently analyzed insurance claims data to assess the veracity of this number. Using the same FDA established criteria regarding serious adverse reactions, it looked at raw data from actual insurance claims. This new study demonstrated that the risk of serious adverse reactions is at least 22 times higher than the rate on the drug label. They looked at data related to 865,727 mifepristone abortions and found the rate to actually be 10.93%. This is a shocking discovery and one most women will not be made aware of before they move forward with plans to take the abortion pill. We are hoping that the FDA will make the necessary changes to better protect women.


